## **Glen's House**

### **Child/Adolescent Crisis Residential**

Glen's House Crisis Residential services provide a safe and therapeutic environment for youth, ages 5-17, with a primary mental health diagnosis and experiencing an acute psychiatric crisis.

Glen's house is intended to provide a short-term (up to 14 nights) stay to:

- youth who are at risk of an inpatient psychiatric admission
- avert an inpatient psychiatric admission
- shorten the length of an inpatient stay

Crisis placements are accepted 24-hours, 365 days a year in a licensed residential facility. Youth can have a co-occurring substance abuse or developmental disability.

On-site crisis services include:

- psychiatric evaluation
- clinical assessment by licensed mental health professional
- treatment planning
- nursing consultation
- medication management/stabilization
- individual, family, and group counseling
- crisis/safety planning



**Youth Crisis Respite** provides a short-term placement for youth, ages 5-17, experiencing a mental health crisis. Services are typically 2-14 days to assist in stabilizing a current (not on-going) crisis situation. Focus is on the temporary separation from youth's natural environment to prevent the risk of deterioration of their mental health condition or harm to themselves or others.

On-site services include:

- continuous observation and supervision
- medication administration
- crisis planning

Crisis Residential/Respite programs operate utilizing **TARGET: Trauma Affect Regulation and Positive Behavior Support (PBS)** curriculum.

During a youth's stay, emphasis is placed on creating an environment designed to support youth in trauma recovery. Each youth will have a comfortable, private room. Residents will be encouraged to participate in structured activities that are scheduled throughout the day. Balanced nutritional meals are provided in a family-like setting.
