## Families Together Building Solutions

FTBS is an in-home program that works with families who are experiencing issues related to child and family well-being and are in need of supportive assistance.

### What can you expect?

Families can expect a strength-based and solution-focused approach. The FTBS Worker will use the family's many strengths to assist them in solving the challenges they are facing. Service areas include:

- Parenting Support/Skills
- Assistance with budgeting
- Connection with community resources
- Communication and conflict resolution
- Building Positive Relationships
- Advocate for services that family desires
- Assistance with Counseling Referrals
- Assist family with household management



### The FTBS program:

- Works with families in their own home
- Has staff available 24/7 if a crisis occurs with the family
- Will work with families during evenings or weekends when necessary
- Provides service to the family for ninety (90) days not to exceed a total of one hundred eighty (180) days of service
- Will average not less than three (3) hours of face-to-face contact per family, per week

### Who can refer?

- Department of Health and Human Services CPS in Kalamazoo and Calhoun Counties
- School Success Coaches in Kalamazoo and Calhoun Counties

### Who is eligible?

Parent or primary caregiver in Kalamazoo or Calhoun County who is responsible for the care and supervision of minor child(ren):

- Who have an open DHHS Category I, II, III, IV, foster care or delinquency case
- Whose open case was closed within the past 18 months
- Who had a CPS investigation within the past 18 months
- Who had 3 or more rejected CPS complaints
- Who have completed Families First services and need additional services
- Who have completed Family Reunification Program and need additional services
- Families open to prevention services with Category IVs having priority
- Families with an open Category I or II and no longer qualify for Families First Services
- Families identified as needing support by a DHHS Success Coach
